

Morocco Town Board Meeting

Tuesday, October 3, 2023

The meeting was called to order at 6:00p.m. Attending the meeting were Board Members Jason Cornell and Nikki Kimbrell. Clerk Treasurer Sherri Rainford, and Town Employees, Dustin Gary and Brian Vanderwall were in attendance.

Town Council

- ❖ Kyle Mark attended the meeting. Dustin wants to print and use the town hall printer. Currently the way it is set up he cannot do that. We have no network for the town or a firewall. Sherri contacted Michael Mark with some solutions to this problem. Kyle presented the board with a quote for \$2337.68. They would come and set this up for us. We can also get new email addresses that match. For example, it would be srainford@townofmorocco.in.gov. Currently Brian has no email, and all board members and employees are different. Jason made a motion to accept the quote and Nikki seconded. Motion passed 2-0.
- ❖ MCO report submitted.
- ❖ Jason made a motion to table the MCO Contract until the next meeting. Niki seconded. Motion passed 2-0. Becky has prepared an addendum to the MCO contract. Sherri will forward it to Nathan at MCO.

Clerk Treasurer

- ❖ Nikki made a motion to approve the claims from September, Jason seconded. Motion passed 2-0.
- ❖ Jason made a motion to approve the September minutes and Nikki seconded. Motion passed 2-0.

Brian Vanderwall- Street Supervisor

- ❖ Approximately we have around 250 meters left to install. Brian and Ernie hope to get them in before the end of November.
- ❖ The dump truck is smoking. Brian thinks it is a plugged injector. He asked permission to take it out to McCool's to see what the cost to fix it would be. He said we don't really need a dump truck that big. Nikki asked him to investigate prices for a new truck. Brian said we could go down to 1 ton.
- ❖ There is a light out at Recher park. Chris Mestrovich is going to fix it. He said the cost would be from \$300-\$800.

Town Marshal (Dustin Gary)

Report submitted

1. Dustin had a quote for new tires for the spare police car. The quote was for \$740.88 from Wonderland tire. Nikki made a motion to accept the quote and Jason seconded. Motion passed 2-0.

Town Attorney (Becky Goddard)

Becky presented the board with a wind power ordinance. She asked that the board table it until next meeting, so they can look it over carefully. Nikki made a motion to table the ordinance and Jason seconded. 2-0.

Becky addressed some false accusations that were said against her. The person that made the accusations was in attendance and a discussion ensued. Becky also said if we don't want our meetings recorded by the public, we need to address that.

Jason made a motion to approve the donation requests and Nikki seconded. Motion passed 2-0.


The meeting was adjourned at 7:00p.m.


