The meeting was called to order at 6:00p.m. Attending the meeting were Board Members Bob Gonczy, and Nikki Kimbrell. Clerk Treasurer Sherri Rainford, and Town Employees, Dustin Gary and Brian Vanderwall were in attendance.

### Town Council

- ❖ Town Clean up was successful. All six dumpsters were filled. Next year we will try and get seven.
- ❖ The Morocco Beaverfest and fireworks were well attended. Bob stated that he had heard nothing but positive things. We need to renegotiate our contract for fireworks before next year.
- ❖ The board discussed the importance of better communication when it comes to calling service people out for repairs with MCO operator Brady Decker.
- ❖ We have a water leak somewhere. Brian thinks he found it on Kabrina. Jr Yoder is going to dig it up this week.
- ❖ The Evapar maintenance agreement was approved. Bob signed the contract and Sherri will mail the check for \$3455. This is a yearly maintenance agreement for the service of the generators.

- ❖ New meters were shipped on June 4, 2023. Brian is hoping to install 5 a day. This is being paid for with the ARP money.

**Town Attorney (Becky Goddard)**


