Tuesday, January 3, 2023

The meeting was called to order at 6:00p.m. Attending the meeting were Board Members Bob Gonczy, Jason Cornell and Nikki Kimbrell. Clerk Treasurer Sherri Rainford, and Town Employees, Dustin Gary, Brian Vanderwall was in attendance.

Town Council

- ❖ Brady Decker from MCO presented the monthly report to the board. A copy of the report is being made a part of the minutes.
- ❖ Our part time employee Ernie Norris can not make over \$13 an hour with his social security. Sherri asked Becky what we can do. Becky said to type up a letter with the lower hourly rate and have Ernie sign it.
- ❖ Moleenar Landscaping gave us a prepayment option for the 2023 summer. This is for Recher and Kessler park. Bob made a motion to prepay for a better rate out of Betty Kessler Park Fund. Nikki seconded; Motion passed 3-0.
- ❖ Bob provided the new board member with a quick overview. A copy of this is being made a part of the minutes.
- ❖ Board member Nikki Kimbrell brought up adding a police protection charge to the monthly utility bills. This would be for Dustin to have a raise and not be paid for out of the General Budget. Becky said she would have to investigate it.

- ❖ Jason made a motion to approve the claims from December 6, 2022, meeting. Nikki seconded. Motion passed 3-0.

Town Marshal (Dustin Gary)

Town Attorney (Becky Goddard)

Becky provided the board with nepotism forms for each member to fill out. Sherri will keep a signed copy.


